The permission form and summary material provide information regarding Cleary School for the Deaf's process for students using school resources on and off the premises. Cleary School for the Deaf will provide your child with a device. Your child will be responsible for it and its care and function.

The devices provided in our 1 to 1 program are intended to empower students to fully participate in a comprehensive educational experience, in-person or online. In preparing your child(ren) for their future, we must provide them with access to tools they may use as adults. Adding opportunities brings increased responsibilities. We have established procedures and rules regulating using Cleary's technology resources. Your child(ren) will be instructed to practice responsible technology use so that Cleary's technology resources remain available for them and their peers. Students will also be directed to access instructionally appropriate content online. A filtering system is used to help prevent access to inappropriate content, no system is perfect and cannot prevent all willful misuse of the internet or school-provided tools.

Legal and Ethical Use Policies

1. Monitoring: Cleary School for the Deaf will monitor 1:1 device usage using a variety of methods to ensure compliance with all applicable policies and this agreement. Any

- attempt to "jailbreak" the device or remove School profiles will result in disciplinary action.
- 2. Legal and ethical use: All aspects of the Cleary School for the Deaf Computer Network and Internet Access Acceptable Use Policy and Responsible/Acceptable Use of Technology guidelines will remain in effect during the use of the 1:1 device. CSFD will make every attempt to provide content filtering within the network and outside the network. However, CSFD does not have full control of the information on the Internet or incoming email while off campus.
- 3. File-sharing and ProxyApps/websites: The installation and/or use of any Internet-based file sharing tools or Proxy Apps/websites designed to circumvent filtering software are explicitly prohibited. File sharing programs and protocols may not be used to facilitate the illegal sharing of copyrighted material (music, video, and images).

By accepting to abide by these policies and expectations, I understand that a device will be provided to my child.
